

Scholarships in 2019 for Hilliard State School



Students at Hilliard excel in various areas of the curriculum. To this end, we wish to support high achieving students and their parents with the opportunity to apply for a scholarship in certain curriculum areas.

In 2019, scholarships each to the value of \$300 will be granted to students who meet criteria in the following domains. \$150 will be credited to the student's account in Term One and the remaining \$150 will be credited in Term Three. The criteria for each domain is listed following each domain heading.

Academic: Two students (To be considered students must be achieving 'B's or higher in English, Maths and Science on their most recent Report Card. Other data that will be considered include the student's performance in NAPLAN (achievement should be in Upper Two Bands); Students achieving a Stanine 8 or 9 in PAT R and PAT M testing and those students selected to join the Children with Potential for Higher Academic Potential (CHIPS) program. Current Class Teacher must support the student's written nomination).

eLearning: Two students (To be considered students must demonstrate adept and innovative skills in the use of ICT. Such students must be able to capably use a range of apps to support and enhance their learning. Membership of and regular attendance at a digital related extra-curricular activity/club will be considered favourably. These skills must have been noted by a Teacher. A Teacher (not necessarily the Class Teacher) must support the student's written nomination).

Aerobics/Hip Hop/Cheerleading: Two students (To be considered students must demonstrate commitment to and skill in one or more of these disciplines. Such students must be enthusiastic and skilful dancers who exhibit an energetic and dynamic on-stage presence. Exemplary attendance and a positive attitude at training is also required. Their talents will have been noted by a coach/Ms Carbone. A Coach/Ms Carbone must support the student's written nomination).

Instrumental Music: Two students (To be considered, students must have already successfully auditioned to be a member of the Hilliard State School Instrumental Band program. Such students must be enthusiastic and skilful musicians who regularly attend rehearsals and who demonstrate a willingness to improve. Their attitude and talent will have been noted by the Instrumental Music Teacher/Classroom Music Teacher. The Instrumental Music Teacher/Classroom Music Teacher must support the student's written nomination).

Guiding Principles

- Students entering Year 4, 5 or 6 in 2019 are eligible to apply for a scholarship.
- Students/Parents are permitted to apply for one scholarship domain only.
- A committee consisting of the Principal, another member of the Management and Leadership Team (MALT), the P&C President and one other P&C delegate will evaluate scholarship applications.
- The nominating student must have a positive behaviour record and display exemplary behaviour for the duration of the scholarship.
- The committee reserves the right to grant or not to grant scholarships depending on the quality of the applications. No correspondence will be entered in to.
- The scholarship is to offset a student's school expenses and can be used for student resources, general excursions and activities. It cannot be used to offset camp fees.
- The Scholarship is for a 12 month period only.
- The student must stay in the relevant program (eg Aerobics) to keep the scholarship.
- Should the student not fulfil the above criteria, the scholarship may be rescinded.
